[REDACTED] has a history of mental illness including a Psychotic Disorder. He currently reported that he has been in prison with the leader of Al Qaida which the FBI and Police have been unable to confirm. He claims he has been receiving death threats from the FBI and that law enforcement agencies are lying about his history. Additionally, he claims to have witnessed many murders throughout his life and experiences frequent anxiety. Additionally, he is paranoid and socially isolates himself from others. Mr. Kabbaj strongly denies the validity of his past diagnosis of Schizophrenia provided by multiple Doctors. He instead claims that his correct diagnosis is Posttraumatic Stress Disorder due to the multiple murders he has witnessed, imprisonment, and physical attacks experienced when he was involved in gang activity.

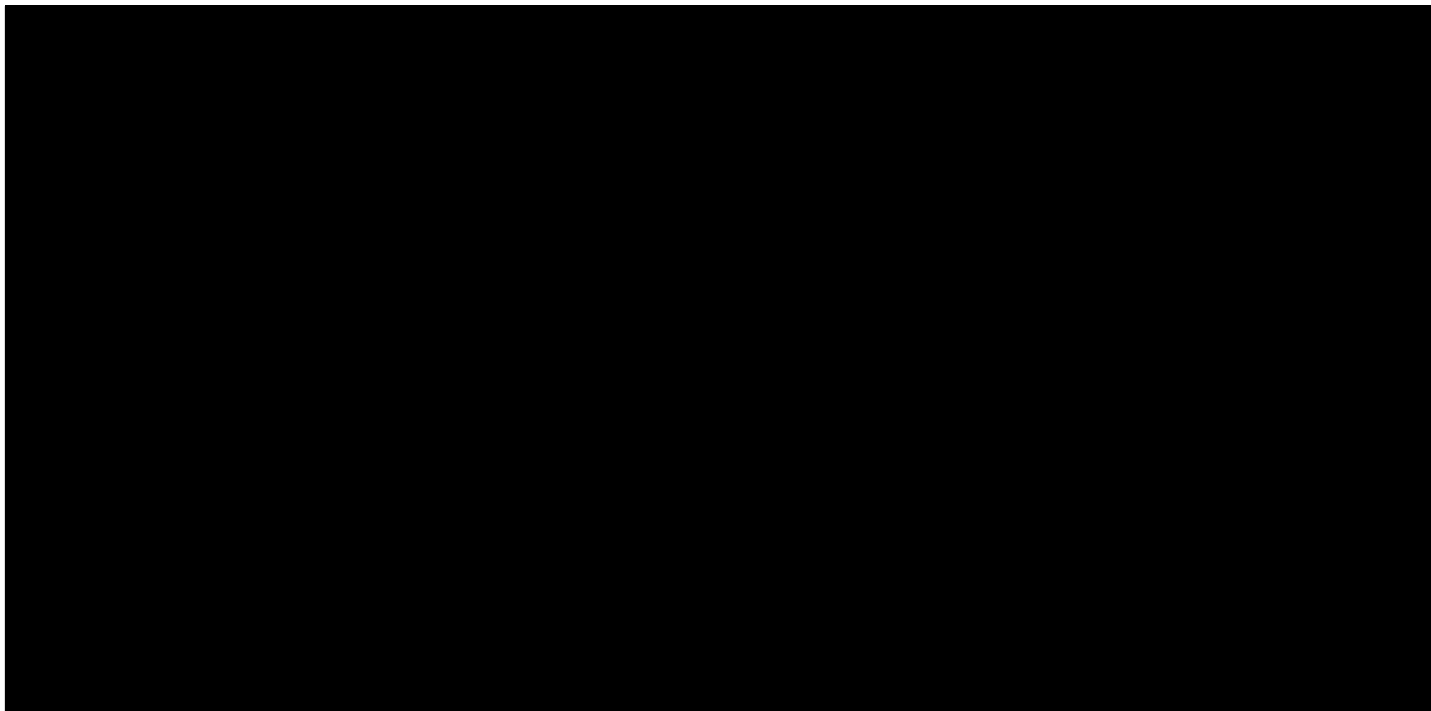

AFFIDAVIT OF SHAWN ██████████

BEFORE ME, the undersigned authority, personally appeared Shawn Regan, who, first being duly sworn, deposes and says:

1. My name is Shawn ██████████ I am 53 years old. I currently reside in Minneapolis, Minnesota. The information contained in this affidavit is truthful to the best of my knowledge and understanding.

2. In 1989, I was charged in a federal drug conspiracy, the United States v. Shawn ██████████. I was imprisoned at the Federal Medical Center at Rochester, Minnesota (FMC Rochester) from 1995 to 1999. I was already an inmate at the facility when ██████████ self-surrendered to the facility in March of 1997 (pursuant to a federal drug conviction out of New York). I befriended ██████████ upon his arrival to the facility. We resided together in Building 2 for the duration of his imprisonment at FMC Rochester.

3. At the end of 1997, I witnessed that the prison authorities were building a cage in the prison’s Chapel Building (religious services building). I also noticed that prison authorities were constructing a secure wing in “Building One” of the prison facility. I did not know the purpose of the cage or the secure wing at that time.

4. Approximately February 1998, I learned that an individual named **Sheikh Omar Abdel Rahman (the “Blind Sheikh”)** was transferred to our facility and housed in the secure wing that was constructed in Building One. I also learned that the Blind Sheikh was being brought to the cage in the Chapel Building to participate in Islamic religious services with ██████████ and

other Muslim inmates. ([REDACTED] was a Muslim participant in those services for the duration of his incarceration both before and after the arrival of Sheikh Rahman).

5. I recall that [REDACTED] informed me that his father had known the Blind Sheikh. I also remember that [REDACTED] stated that he witnessed Sheikh Rahman being abused during a religious service which may have been video recorded. I was not present at the religious service to witness this abuse directly.


6. I recall that [REDACTED] was released from FMC Rochester approximately May of 1998, and we have remained good friends since we first met in 1997. In the 24 years that I have known [REDACTED] and maintained a close friendship with him, I have never witnessed him engage in any delusional thinking, hallucinations, or exhibit any sign of a mental disorder.

7. I have since learned that people are falsely accusing [REDACTED] of hallucinating his contact with Sheikh Rahman at FMC Rochester. This is absurd. Dozens upon dozens of other inmates that I witnessed (to include the entire Muslim population of the prison) were directly aware that the Blind Sheikh was residing at the prison. FMC Rochester is known to house celebrity inmates, and this was a prominent feature of the prison.

8. [REDACTED] and other Muslim inmates (to include another inmate we knew as "Smiley") would provide me details of their interactions with Sheikh Rahman during many public discussions occurring between numerous inmates at the prison. Their testimony confirmed that Sheikh Rahman was participating in the religious activities of the Muslim community at the prison (to include the Friday prayer services). As such, it was clear to me that [REDACTED] and other Muslim inmates were in direct communication with Sheikh Rahman during their incarceration together. If people are claiming that [REDACTED] is hallucinating

these facts, they are wrong. I directly witnessed [REDACTED] and other Muslim inmates describing their various interactions with Sheikh Rahman at the prison. [REDACTED] is undoubtedly in a position to be able to testify about whatever he witnessed concerning Sheikh Rahman (as his direct contact with Sheikh Rahman at FMC Rochester was not born of delusion).

9. During my time in federal prison, I directly witnessed substantial corruption by prison officials and guards. It is not uncommon for guards to physically abuse inmates. Although I did not directly interact with the Blind Sheikh because I was not a member of the Muslim congregation (as only the Muslims were allowed contact with him during Islamic activities), I believe [REDACTED] regarding anything he claims to have witnessed at the prison since he first described these events to me when we were imprisoned together. I have never witnessed [REDACTED] lie about anything in the 24 years that I have known him thus far.


