Also with regards to the other recordings mentioned in the affidavit (regarding the crime unrelated to [REDACTED] that I risked my life to make additional recordings in November 1996), these additional recordings can be heard here:

These recordings were made on 11/3 and 11/4 of 1996, and I risked my life to make them without assistance from Police because if my recorder had been discovered, I would have been immediately killed on the spot. In the recording you will see an individual named Raoul Campana admit to participating in the murder of Mohammed Syed. That recording should have immediately resulted in a 1st degree murder conviction for Mr. Campana and three other persons (to include the Italian mafia hitman who actually pulled the trigger). At the time I made the recording, I was already aware of a plot to murder Mr. Campana (orchestrated by the Italian mafia hitman and his crew), and at the same time Mr. Campana was himself plotting to murder another witness to this crime who was hiding out in Pakistan (an individual named Abid Chaudhry who was also known to [REDACTED]). Because the DEA refused to allow me to cooperate in that murder investigation (as well as all the others, to include the [REDACTED] investigation), Mr. Campana was subsequently murdered in May of 1997 (a murder that was easily preventable had the DEA heeded my warnings that other witnesses were going to be killed). I would later track the murder victim of Mr. Campana as being a member of the same terrorist sleeper cell as Daoud Gilana aka David Headley.

Years later I tracked down AUSA Dorsky to confront him about the crime he committed on my case by refusing to allow me to cooperate in all these matters, here is the conversation:

If I disappear, probably the best place to look is Federal BOP inmate locator (I also put an inmate locator app on my website at fedrap.com if it is easier to use mine). Hopefully they don't try it again this election cycle.

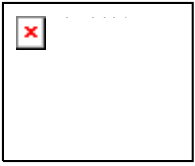
